SAFETY AND SYSTEM UPDATE

President and Chief Executive Officer Thomas J. Kent introduced a conversation related to the recent cold weather event and subsequent emergency load shedding dictated by the Southwest Power Pool (SPP).

FEBRUARY 2021 WEATHER EVENT AND SPP **EMERGENCY LOAD** SHEDDING

System Control Manager Ron O. Gunderson presented specifics related to the shedding of load from the transmission perspective, including a timeline, steps taken, breakers opened each day during the event and a summary of outage durations, and discussed lessons learned and next steps.

Vice President of Energy Production Michael J. Spencer presented information related to the load shedding event from the energy supply perspective, and discussed energy market and natural gas supply, NPPD's dispatchable generating units, NPPD generation compared to load. and preliminary lessons learned.

Questions were fielded and answered during and after the presentations.

President and Chief Executive Officer Thomas J. Kent provided opening comments for the Carbon Business Risk Reduction Options Initiative. A team of NPPD staff and customers, with assistance from external subject matter experts and facilitators, held several meetings from June 2019 to January 2020 to develop a common understanding of the issues and business risks concerning future carbon regulations. As a result of these sessions, NPPD retained the services of two consultants to provide two different analyses to allow for a better understanding of the related cost drivers; the consultants were tasked with developing scenarios and models for the 2021-2050 time period. Presenting the results of their analyses and models were David Millar of Ascend Analytics, and Eric Krall and Michael Korschek of Siemens.
