

Need & Benefit Norfolk Area Transmission System

- The electric load in Stanton, Cuming, and Burt Counties continues to grow, and the existing 115 kV transmission system is facing high electrical demand.
- In exploring several different options, NPPD and SPP determined a 115 kV transmission line from the Norfolk substation on the east side of Norfolk to the Stanton North substation northwest of Stanton will accommodate current and projected future loads.
- The new line will provide additional reliability and enhanced resiliency.

- The new Norfolk Stanton North transmission line project received a Notification To Construct from SPP
- NPPD Board of Directors has approved NPPD's commitment to construct this new network upgrade




