2024 Legislative Session

NR Committee Priority Package #1 – Carrier Bill 867 – Final Reading

- LB 867 (Bostelman) Provide for voluntary hunting & fishing guide & outfitter database
- LB 866 (Bostelman) Change provisions relating to service on the Nebraska Power Review Board
- LB 868 (Bostelman) Extend the sunset date for reimbursement for remedial action under the Petroleum Release Remedial Action Cash Fund
- LB 971 (Lippincott) Provide for a free hunting permit for veterans to hunt on Veteran's Day
- LB 1001 (Conrad) Provide for a migratory waterfowl hunting season for veterans
- LB 1406 (Sanders) Provide for an active-duty military permit for state park entry
- LB 636 (Albrecht) Prohibit political subdivisions from restricting certain energy services

2024 Legislative Session

NR Committee Priority Package #2 – Carrier Bill 1370 – Final Reading

- LB 1370 (Bostelman) Provide requirements for retirement of a dispatchable electric generation facility by an electric supplier
- LB 120 (Bostelman) Eliminate obsolete provisions relating to a Nebraska Power Review Board Study
- LB 956 (Bostar) Provide requirements for light-mitigating technology on certain wind turbines
- LB 969 (DeKay) Change provisions relating to contracts & sealed bids for public power districts
- LB 1260 (Jacobson) Provide authority for public power and irrigation district directors to take action on certain agreements in which they have an interest

2024 Legislative Session

Government, Military & Veterans Affairs Package #3 – Carrier Bill 1300 – **Final Reading**

- LB 1300 (Bostar) Adopt the Pacific Conflict Stress Test Act and the Foreign Adversary Contracting Prohibition Act (At the Request of the Governor; Senator Ballard Priority)
- LB 2 (Sanders) Create the Commission on Asian American Affairs
- LB 869 (Bostar) Change provisions relating to services of the county veterans service committees
- LB 887 (Brewer) Adopt the Nebraska Nonprofit Security Grant Program Act
- LB 1048 (Bostar) Require certain chemical facilities to comply with a federal chemical security program
- LB 1243 (McDonnell) Adopt the Wildland Fire Response Act
- LB 1358 (McDonnell) Require approval of the registered voters to increase salaries of governing bodies of political subdivisions as prescribed

2024 Legislative Session

Bills of Interest:

- 61 (Brandt) Authorize leasing of dark fiber and eliminate certain powers of the Public Service Commission – Passed
- 399 (Brewer) Change provisions relating to privately developed renewable energy generation facilities and other electric generation facilities (Bostelman PB) – Final Reading
- 541 (Lowe) Change provisions relating to election of public power district directors – Select File
- 1218 (Bostar) Provide for motor vehicle registration of certain electric vehicles, impose an excise tax on electric energy used at commercial electric vehicle charging stations, provide for regulation of certain charging stations, and provide a sales tax exemption for certain electric energy -> Now LB 1317 (Linehan) Revenue Package #3 - Final Reading
