NPPD Retail Service Rules and Regulations

Retail Service Rules and Regulations include requirements under which the District provides retail service to its customers.

NPPD Retail Service Rules and Regulations Proposed Change

Section 2.B(2) Customer Deposits (Page 5)

Nonresidential Deposits <u>less</u> than 5MW: Applicable to new nonresidential Customers loads less than 5 MWs.

Option 1 = Two (2) times the highest estimated monthly bill (but not less than \$225). If the deposit amount exceeds \$500, 50% will be due at the time service is requested with the remainder billed to Customer. A deposit is not required if the customer has an existing account with the District which has the same Federal Tax ID as the new account, the deposit on the existing account had previously been or is currently being held for a minimum of 4 years, and the existing account has established an excellent credit history for the past twelve (12) months.

NPPD Retail Extension Policy

Retail Extension Policy includes requirements under which the District provides new retail service or extends existing retail service to its customers.

- Overhead and Underground Extensions
- Subdivisions
- Customer Responsibilities
- Allowable Investment Limit and Customer Contribution in Aid of Construction

NPPD Retail Extension Policy

Proposed Changes

- General Clarifications
- I.C.4 Subdivisions
 - Added bullet to require all easements related to electrical facilities are reviewed and approved by NPPD and included in final plat.
- I.D.3 Underground Extensions
 - Customer shall reimburse NPPD for primary, secondary, and streetlight trench and conduit installation.
- I.E.2 Recalculation of CIAOC
 - Within one year of initial in-service date, customer may request or NPPD may perform a review of actual load, CIAOC may be recalculated and adjustment made to customer account for the difference.
